DELAWARE TITLE 21, SECTION 2502 REQUIRES THE REGISTERED OWNER OF A VEHICLE TO NOTIFY THE DIVISION OF MOTOR VEHICLES OF THE SALE OR TRANSFER OF A VEHICLE. THE SELLER IS ALSO REQUIRED TO SEND THE REGISTRATION CARD TO DMV, EXCEPT WHEN THE VEHICLE IS SOLD/ TRANSFERRED TO A DEALER. IN THAT CASE, GIVE THE DEALER THE REGISTRATION CARD AND MAIL THIS FORM TO DMV. VIOLATORS OF SECTION 2502 ARE SUBJECT TO A FINE AND/OR IMPRISONMENT.

DMV RECOMMENDS THAT THE SELLER SHOULD TRANSFER THE TITLE TO THE BUYER AT DMV. THIS WILL ENSURE THE BUYER ACTUALLY GETS A NEW TITLE FOR THE VEHICLE AND ENSURES YOUR NAME IS REMOVED AS THE VEHICLE OWNER.
